

La Roche-Posay One (1) Year Limited Warranty – My Skin Track (Hardware Only)

This La Roche-Posay One-Year Limited Warranty is a voluntary warranty and is applicable to Your La Roche-Posay My Skin Track Sensor hardware product sold in Denmark. It provides rights separate to rights provided by consumer law, including but not limited to those relating to non-conforming goods. As such, the La Roche-Posay One-Year Limited Warranty benefits are in addition to, and not instead of, rights provided by consumer law and it does not exclude, limit or suspend a buyer's rights arising from consumer law. Consumers have the right to choose whether to claim service under the La Roche-Posay One-Year Limited Warranty or under their consumer law rights. Important: The La Roche-Posay One-Year Limited Warranty terms and conditions shall not apply to consumer law claims.

Please note: All claims made under the La Roche-Posay One-Year Limited Warranty will be governed by the terms set out in this warranty document.

Your La Roche-Posay My Skin Track Sensor hardware product ("Product") is warranted against defects in materials and workmanship for a period of ONE (1) YEAR from the date of original retail purchase ("Warranty Period") when used in accordance with La Roche-Posay's user instructions, including but not limited to specifications for use of the Product with third party hardware (e.g., compatible mobile devices) and the My Skin Track software application, as updated from time to time. If a defect arises during the Warranty Period, La Roche-Posay (via Apple stores), at its option will (1) exchange the Product with a product with equivalent functionality formed from new and/or previously used parts that are equivalent to new in performance and reliability or with your consent, a product that is at least functionally equivalent to the product it replaces, or (2) refund the original purchase price. This warranty excludes normal depletion of consumable parts such as batteries unless failure has occurred due to a defect in materials or workmanship and, damage resulting from abuse, accident, modifications, unauthorized repairs or other causes that are not defects in materials and workmanship.

Please note: This Limited Warranty covers the My Skin Track hardware Product only and does not cover the My Skin Track software application.

La Roche-Posay Denmark will provide warranty service through return to Retailer. You may return your defective Product to the authorized retailer where you purchased your Product.
